Inspection can be undertaken between the hours of 10.00am and 4.00pm; Monday to Friday and copies can be made of all related books, deeds, contracts, bills, vouchers and receipts and other documents relating to them (please note, copies of all, or any part of the accounts, or those documents referred to above may be subject to payment of a copying charge).
