**Allocate £15,000 to the Northamptonshire Business Crime Partnership, Retail Crime Initiative, to support Retail Crime Initiative.**

### Details of advice taken

Advice taken consisted of a presentation from the Board of Directors of NBCI (Mike Brennan) and operational lead (Alison Farr). Additionally advice sought from Paul Fell, Director of Delivery as well as informed by two recent national reports relating to business crime. The first of these reports related to the rise in retail crime, mainly shoplifting and the current economic position of the retail sector and the second related to the increasing level of assaults on staff employed across the retail sector.

#### 1. Purpose of Report

- 1.1 The Northamptonshire Business Crime Partnership is a not for profit organisation working in partnership with a number of businesses and organisations, including Northamptonshire Police.
- 1.2 It's aims are to reduce retail crime and anti-social behaviour in all shopping areas across the County.
- 1.3 The partnership runs a retail crime initiative, which started in Northampton in 2001 but has grown to include many areas of Northamptonshire.
- 1.4 RCI allows an on line reporting and information sharing platform for all retailers that are a part of the scheme. This allows effective and timely crime recording for them and reduces associated workloads and demand for Northamptonshire Police.
- 1.5 RCI has a business plan to become self-sustaining in terms of funding over the next 24 to 30 months.

#### 2. Decision(s) Recommended:

- 2.1 To provide the sum of £15,000 to Northamptonshire Business Crime Partnership to support the ongoing development of Retail Crime Initiative over the next 18 months.

#### 3. Relevant background / Chronology of Key Events:

- 3.1 A focus of the Police and Crime Plan and overarching aim of the PCC is to ensure a safer Northamptonshire. This supports this aspiration by supporting a more effective response to this type of retail crime, through effective reporting, supporting investigations and assisting in information and intelligence sharing.

3.2 This funding will allow the RCI to continue in it's current form, as well as allowing it to broaden it's reach into Daventry and South Northamptonshire and parts of East Northamptonshire.
